Alignment of Vocational Education from Secondary to Higher Education

1.0 Background

The National Education Policy (NEP) 2020 is a comprehensive policy document that also extensively discusses the need for revamping of vocational education. The policy focuses on bringing vocational education into mainstream education, as also recommended by earlier committees and commissions on education.

The reluctance of the students to join vocational courses at the higher secondary level is mainly due to the absence of vertical mobility. It is observed that the lack of horizontal and vertical mobility in the absence of non-alignment of the curriculum of vocational courses in higher education institutions are some of the reasons why students are reluctant in opting for vocational courses, even though they find them more relevant to their needs, interests, and aptitude.

The NEP 2020 aims to overcome the social status hierarchy associated with vocational education and advocates integration of vocational education programmes into mainstream education in all educational institutions in a phased manner. It has suggested that vocational exposure at early ages in middle and secondary school and ensuring quality vocational education in schools and higher education institutions will make vocational education attractive to the students. It also suggested that there is a need to ensure that every child learns at least one vocation and is exposed to several more. The target set by the NEP 2020 is that by 2025, at least 50% of learners through the school and higher education system shall have exposure to vocational education, for which a clear action plan with targets and timelines will have to be developed. To achieve this target, the higher education institutions will have to offer vocational education either on their own or in partnership with industry and NGOs. The Bachelor in Vocational Education (B.Voc.) degrees introduced in 2013 will continue to exist, but vocational courses will also be available to students enrolled in all other Bachelor's degree programmes, including the 4-year multidisciplinary Bachelor's programmes.

As per the recommendations in the NEP-2020, there is a need to align vocational education in school education to higher education. For aligning the vocational courses running under both levels of education there is a need for collaboration between the stakeholders of school and higher education. Vocational education will be integrated into all school and higher education institutions in a phased manner over the next decade. Different models of vocational education, and apprenticeships, will also be experimented with by higher education institutions. The vertical progression in vocational education would need to be strengthened so that the vocational pass-out students of schools can enter vocational courses offered by Schools, Industrial Training Institutes, Polytechnics, and higher education, including Bachelor of Vocational Education (B. Voc).

A credit-based framework will facilitate mobility across "general" and "vocational education". The School Education Department in coordination with the Department of Higher and Technical Education of the State/UT may create more avenues for vertical mobility like introducing, Diploma, B. Voc. courses in technical institutions and universities. They may assist and facilitate the students in pursuing higher education in vocational subjects. School vocational education qualifications should be recognized by higher education institutions at par with academic qualifications for admission to diploma and degree courses.

The Ministry of Education (previously Ministry of Human Resource Development), Ministry of Labour and Employment, Ministry of Skill Development and Entrepreneurship, and National Skill Development Council are the primary agencies responsible for the implementation of vocational education and training in the country. Thus, to bring in systemic change as recommended by NEP 2020, it will require the capacity building of the stakeholders in VET working for the various skill development schemes or programmes under the various Ministries.

With the world moving towards a digital order and NEP 2020, technology-based skills, especially among the youth, have become more critical than ever. To effectively implement the recommendations in the NEP 2020, the government and stakeholders need to focus on re-vamping the vocational education and training system under School and Higher education levels.

The PSS Central Institute of Vocational Education (PSSCIVE), Bhopal is organising an online 'National Meeting-cum-Workshop on Alignment of Vocational Education from Secondary to Higher Education to deliberate upon the various challenges and issues related to horizontal and vertical mobility of vocational students and strategic actions to be taken for facilitating horizontal and vertical mobility of the vocational students and implementation of the recommendations of National Education Policy 2020 about vocational education.

2.0 Objectives

The objectives of the National Meeting-cum-Workshop are to:

- i. provide a platform for the exchange of information regarding vocational courses implemented at School and Higher Education;
